We have 27 stations serving Downtown, Westport, the Country Club Plaza, 18th & Vine Jazz District, and the Trolley Track Trail. We are an innovative solution for transportation, recreation, and physical health. In 2015 the size of the system grew by 30% while ridership more than doubled to 13,285 trips. Our users travelled 48,702 miles, offset 46,132 pounds of carbon, and burned 1.9 million calories.
