Bike Share KC Administrative Support Services: To support services for Bike Share KC, a tax exempt organization whose mission is to provide the B-cycle bike share system in the Kansas City area. In 2016, Kansas City B-cycle grew to a network of 30 stations and 160 bikes. Usage increased 26% to 16,700 trips, which resulted 86,000 miles bike, 81,000 pounds of carbon offset, and 3.4 million calories burned.

4b (Code:) (Expenses \$ 134,759. including grants of \$) (Revenue \$) Youth Education: A comprehensive education and youth program that empowers youth to safely bike and walk to school, and to advocate for their neighborhood. Components include bicycle safety education, youth ambassador training, earn-a-bike, and public engagement. This year the program served more than 3,600 kids in 45 schools across the metro area, especially in the urban core and firstring suburbs.

4c (Code:) (Expenses \$ 28,219. including grants of \$) (Revenue \$ 10,838.) Advocacy, Public Policy, and Consulting: Work with local municipalities and school districts to improve walking and biking, including public policy, technical assistance, and school travel planning. Significant work in 2016 included sidewalk policy development in Kansas City, MO and sidewalk investment planning in Kansas City, KS.
