We have 41 stations serving North Kansas City, the River Market, the 18th & Vine Jazz District, Downtown, Westport, the Plaza, Trolley Track Trail, Brookside, and Waldo, as well as a station at Longview Lake. We provide an innovative solution for transportation, recreation, and physical health. In 2017, ridership increased by 17% to 19,499 trips. Our users travelled 87,452 miles, offset 82,785 pounds of carbon, and burned over 3 million calories.
