OUR VISION IS A GREATER KANSAS CITY WHERE EVERYONE CAN MOVE THROUGH THE REGION AND ITS PUBLIC SPACES EQUITABLY, SAFELY, COMFORTABLY, AND SUSTAINABLY.

RIDEKC BIKE: A 24/7 PUBLIC BIKE SHARE SYSTEM PROVIDING A UNIQUE MIX OF TECHNOLOGIES THAT EXTEND THE FIXED-ROUTE TRANSIT SYSTEM AND GIVES LOCAL RESIDENTS AND VISITORS A VARIETY OF OPTIONS FOR GETTING AROUND THE GREATER KANSAS CITY REGION. IT FEATURES SMART ELECTRIC BIKES, CLASSIC PEDAL BIKES, AND PROGRAMMING DESIGNED TO OFFER INNOVATIVE SOLUTIONS FOR TRANSPORTATION, RECREATION, AND PHYSICAL HEALTH. IN 2021, WE COMPLETED TWO NEW EXPANSION PROJECTS. RIDERSHIP GREW SIGNIFICANTLY, WITH A 25% INCREASE FROM 2020. FOR 2021, THERE WERE A TOTAL OF 33,647 TRIPS, 350 BIKES WERE DEPLOYED, MORE THAN 82,000 MILES WERE RIDDEN, AND WE HELPED OFFSET 70,836 POUNDS OF CARBON.

4b (Code:) (Expenses \$ 307,684. including grants of \$) (Revenue \$) FAMILY EDUCATION: BIKE WALK KC'S YOUTH EDUCATION PROGRAMS EMPOWER KIDS TO SAFELY BIKE AND WALK TO SCHOOL AND TO ADVOCATE FOR THEIR NEIGHBORHOOD. THEY INCLUDE BICYCLE SAFETY EDUCATION, YOUTH AMBASSADOR TRAINING, MAINTAIN YOUR RIDE, PUBLIC ENGAGEMENT, AND OPPORTUNITIES TO "EARN A BIKE". DESPITE COVID-19'S CONTINUED IMPACT, BIKE WALK KC SERVED 3,731 KIDS (41% INCREASE OVER 2020). OF THOSE, 303 LEARNED TO RIDE A BIKE FOR THE FIRST TIME. WE PROVIDED 1,410 FREE HELMETS TO KIDS ACROSS THE REGION. IN 2021, 164 ADULTS PARTICIPATED IN PROGRAMS SUCH AS CONFIDENT CITY CYCLING AND MAINTAIN YOUR RIDE. WE ALSO OFFER PROGRAMS SPECIFICALLY FOR WOMEN AND INDIVIDUALS WHO IDENTIFY AS FEMALE OR NONBINARY. THEY ARE DESIGNED TO TEACH SAFE RIDING SKILLS, THE RULES OF THE ROAD, AND HOW TO DO BASIC BIKE MAINTENANCE AND REPAIRS.

WE BUILD RELATIONSHIPS WITH ELECTED OFFICIALS TO IMPLEMENT POLICIES THAT IMPROVE THE BUILT ENVIRONMENT, ESPECIALLY IN NEIGHBORHOODS THAT HAVE BEEN HISTORICALLY UNDERFUNDED. BIKE WALK KC ALSO WORKS WITH LOCAL MUNICIPALITIES, SCHOOL DISTRICTS AND REGIONAL, STATE, AND FEDERAL AGENCIES, AS WELL AS OTHER ACTIVE TRANSPORTATION ADVOCACY ORGANIZATIONS ACROSS MISSOURI AND KANSAS. IN 2021, WE DELIVERED TARGETED CAMPAIGNS IN SUPPORT OF ACTIVE LIVING AND CHANGES TO THE BUILT ENVIRONMENT, AS WELL AS MOBILITY JUSTICE ISSUES (FOR EXAMPLE, SUCCESSFULLY OVERTURNING JAYWALKING LAWS THAT LEAD TO OVER-POLICING IN BLACK AND BROWN COMMUNITIES, AND WHICH DO LITTLE TO KEEP PEDESTRIANS SAFE).
