IT FEATURES SMART ELECTRIC BIKES, CLASSIC PEDAL BIKES, AND PROGRAMMING DESIGNED TO OFFER INNOVATIVE SOLUTIONS FOR TRANSPORTATION, RECREATION, AND PHYSICAL HEALTH. IN 2023, RIDERSHIP CONTINUED TO GROW AS WE EXPAND OUR SERVICE AREA AND NUMBER OF BIKES DEPLOYED. TRIP RATES IN 2023 ON BIKES WERE UP BY 25% AND TOTAL TRIPS INCREASED BY 8% OVERALL.
