BIKE SHARE KC (FORMERLY RIDEKC BIKE) IS A 24/7 PUBLIC BIKE SHARE SYSTEM PROVIDING A UNIQUE MIX OF TECHNOLOGIES THAT EXTEND THE FIXED-ROUTE TRANSIT SYSTEM AND GIVES RESIDENTS AND VISITORS A VARIETY OF OPTIONS FOR GETTING AROUND THE GREATER KANSAS CITY AREA. IT OFFERS SMART ELECTRIC BIKES, A FEW CLASSIC PEDAL BIKES, AND PROGRAMMING THAT PROMOTES SAFE BICYCLING FOR TRANSPORTATION, RECREATION, FITNESS, AND A MORE SUSTAINABLE NATURAL ENVIRONMENT. IN 2025, THERE WERE 400 BIKES IN SERVICE. MORE THAN 4,700 UNIQUE USERS TOOK 27,604 TRIPS; RODE 64,000 TOTAL MILES; OFFSET 66,000 POUNDS OF CARBON; AND BURNED 4.5 MILLION CALORIES.
